We do not have knowledge of the monies that may have been collected on behalf of the corporation and the former treasurer now President upon emergency reorganization on 3/30/2024 to comply with the laws and organize under his fiduciary duties and file Annual Report with the State. and have set up a chart of accounts and Bank Account and the new Board of directors have voted to remove all but the original treasurer who filed the Articles of Incorporation and tried to get the other initial directors to call the proper meetings and organize.

We will be filing a formal request of information as to all monies received on behalf of the corporation, in kind donations and records as to the distribution of said receipts and the corporate books. and Notify the IRS as to the date of request and any failure to provide the information for action.

I will provide the IRS with an accounting of Liabilities that I am aware of and an accounting of the current status of the books for this corporation since the reorganization but will not sign a return under penalty of perjury as to any funds that may have been received by the removed president John Ramos but will provide a SSAN for 2023
